**Title: Committees** 

**Reference:** The Doctrine and Discipline of the AME Church 2016, Article XIV, Section 2, page 491.

Intent: To amend the standing committee to include Budget and Finance Committee.

Rationale: In order for the organization to run efficiently the Budget and Finance Committee should be a Standing Committee that works not only during the convention but throughout the year to ensure the budget is functioning to its fullest ability.

Current Text: Article XIV, Section 2, page 491 reads Standing Committees shall be the following: Proposed Legislation, Constitution and Bylaws and AME V-Alert.

Amended Text: Article XIV, Section 2, page 491 amends to read, Standing Committee shall be the following: Proposed Legislation, Constitution and Bylaws, AME V-Alert and Budget and Finance.

### **AMENDMENT**

- Title: Membership
- Reference: The Doctrine and Discipline of the AME Church 2016, Article IV, Section 2b, page 473.
- Intent: To move the office of President Emeritus from a voting member position to a position of honor with the role and qualifications of the office of President Emeritus define in the Bylaws.
- Rationale: To really define this role so that every Past President is not automatically considered President Emeritus. Also, what financial obligation is connected to this position?
- Current Text: Article IV, Section 2b, page 473 reads all persons holding the designation and/or office of President Emeritus.
- Amended Text: Delete Article IV, Section 2b. Add to Bylaws of the Connectional Lay Organization as Section 10, page 496. President Emeritus must have served eight years as Connectional Lay President. Be an active member of the Connectional, District and Conference levels. Receive 25% discount on registration, if not already a register delegate. No voting privilege. No financial compensation.
