The duly elected delegates of districts one thru thirteen and sixteen were sitting in a cold ballroom at the Orange County Convention Center in Orlando, Florida while the delegates of districts fourteen, fifteen, seventeen thru twenty joined via Zoom. It was Sunday, July 11, 2021, and shortly before the 5 pm hour. The Second Business session of the 37th Biennial Session of the Connectional Lay Organization of the African Methodist Episcopal Church had come to order after a short break and the order of the day was for the election of the new officers of the organization. We all just heard the final report of the Credentials Committee. President Matikane "Abe" Makiti was plastered on every screen as he called for the report of the Nomination Committee.

The Chairperson of the Nominating Committee, Dr. Felicia Commodore, stepped up to the podium to give the report. The report outlined the work of the committee and most importantly the final ballot for the pending election. All positions were available in this election. Several positions were unopposed this year and they were: First Vice President, Treasurer, Financial Secretary, Recording Secretary, Corresponding Secretary, Young Adult Representative, Historiographer, and Chaplain. After the recent update of the withdrawal of Amanda Johnson from the race of the Third Vice President, the majority of the opposed contest only had two candidates. The single race with more the two candidates was at the top of the ticket, President. The committee reported there were no candidates for the office of Parliamentarian. Dr. Commodore finished the report with thanks to the Co-chairperson Bro. Michael Brown and others for their support. The report was accepted by the body. We officially have a ballot for the election.

It was now time for the election to begin. The Election Committee was summoned to present their report. Judge Patricia Mayberry, Election Committee Chairperson, came forward to present the report. In the report, she presented the rules and process of the election of the officers of the Connectional Lay Organization. After some questions and clarification, the report of the Election Committee was accepted also. And so it begins. The first item of business was the offices that were unopposed. According to the rules set forth by the Election Committee, these officers would be elected by voice vote. #### THREE IMPORTANT FACTS TO REMEMBER AND SHARE WITH OTHERS:

Doctors and researchers are still learning about the Delta variant, but they know many things so far. Here are three things that everyone should know:

- 1. The Delta variant is more contagious than other SARS-CoV-2 virus strains. Research has shown that the Delta variant spreads more easily between people, and it appears that people are transmitting the virus to others sooner than people spread the original strain of the novel coronavirus. Additionally, one recent study from China found that people who were presumably unvaccinated and infected with the Delta variant had a viral load within their respiratory systems that was 1,000 times higher than the amount of virus that was present among people who had been infected by the original strain of the virus.
- The combination of a higher viral load, the ability to spread the virus to others earlier (when people may not realize that they're sick) and the fact that this variant spreads more efficiently makes the Delta variant worrisome. The Centers for Disease Control and Prevention (CDC) has classified it as a "variant of concern," which is a term that's used when a virus is more transmissible, causes more severe disease or involves other complications.
- 2. People who are infected with the Delta variant may get sicker. Recently published research from Scotland has shown that unvaccinated people who are infected with the COVID-19 Delta variant are twice as likely to be hospitalized, due to severity of illness, than people who are infected with the COVID-19 Alpha variant, which had previously been identified as more contagious than the original strain of the virus. More research is needed to determine whether the Delta variant causes more severe illness than other strains, but the presence of a higher viral load may contribute to more symptoms among affected people.
- 3. <u>COVID-19 vaccines offer the best protection against the Delta variant.</u> The current research suggests that the COVID-19 vaccines that are available within the U.S. adequately protect against the Delta variant, although researchers will continue to study their effectiveness.

The CDC recommends that people who aren't vaccinated should get the COVID-19 vaccine to protect themselves from the risk of illness from COVID-19, including the Delta variant. In the event that someone who is vaccinated gets COVID-19, the vaccines protect against the severity of illness, which helps to prevent hospitalization and death.




